# University Athletics Academic Advisory Committee September 7, 2011

The meeting opened at 4 pm. Campbell moved to approve the minutes from last month's meeting, and Malta seconded. There was no old business. Bennett then turned the floor over to our reports:

### **AD Report**:

Our fall season is underway. Staub expressed great pride in the Volleyball team, which is now 3-0. Soccer is currently at .500, which is a great improvement over last season. Staub also expressed pride in our football team after a hard game at FSU, pointing out that we played well defensively.

Our first home game is Saturday, September  $10^{th}$  at 6 pm against Grambling State. "Our ticket office is very, very busy. . . Saturday is a huge event for us."

Staub briefly discussed the shuffling among college conferences. ULM is carefully watching the situation.

Several reviews are currently underway, and these will be incorporated into the Strategic Plan.

#### **Senior Compliance Administrator Report**:

Fisher distributed and explained background on APR. APR was established in 2003-04 to measure the academic achievement of each Division I team over each term. APR scores range from 1000 (perfect) to 925 (minimum acceptable score). Schools that fall below 925 "face possible sanctions ranging from scholarship reductions to more severe penalties" (NCAA). Fisher stated, "Once our data is submitted for this year, we will see marked improvements over last year's scores." Ograk asked if any ULM teams have fallen below the 925 mark. "Yes, men's basketball has lost three scholarships, practice time, and the possibility of post-season play." Football and men's and women's track have lost scholarships. Michaelides asked if we can regain these scholarships. "Yes, when these scores reach 925."

Fisher will submit our latest APR data to the NCAA at the end of September.

### **FAR Report:**

Bennett will meet with Sunbelt FAR Association later this semester, and he will also attend the national FAR Association meeting in San Diego in November. He is currently learning his FAR duties and has studied the description of responsibilities from other Sunbelt institutions.
