





Northeast Louisiana is a 12-parish area bordered to the north by Arkansas and to the east by Mississippi. The Monroe metropolitan statistical area (Ouachita and Union Parishes: MSA rank by 2009 population=229/366) is the population and business center for the greater area. The data contained herein is compiled from many sources and is as current as availability permits.

Population growth in the region continues to be weak. Of course, population change is tied mostly to job growth and availability. Northeast Louisiana, a largely rural area surrounding the Monroe MSA, saw an uptick in employment growth in 2009 with some promise for expanded significant growth in the near term. Much of the anticipated change in employment opportunities are tied to the ConAgra Foods project, consolidation by Gardner Denver Thomas, the CenturyTel-Embarq merger (now CenturyLink), and the considerable anticipated impact of the V-Vehicle auto assembly plant, the latter of which is still pending. If V-Vehicle begins and maintains operations in the region, that plant alone could provide the basis for a spike in population.

For 2009, however, estimated annual growth for the region was 575 people, .1%. Growth in Ouachita parish is considerably greater due primarily to the intraregional inmigration of formerly rural parish residents.







Millage rates vary between and within Parishes. Some Parishes have numerous rates that are votingward specific. The rates given in the adjacent listing are the range of millage rates within each Parish and can be used to estimate the (range of) expected property tax liability.

Millage rates shown were obtained via telephone interviews with Parish Assessors' offices.

To calculate the taxes on your primary home, you must take the assessed value, which is a percentage of "fair market value," and multiply it by the appropriate tax or millage rate to arrive at the amount due.

If, as an example, you had \$1000 of taxable assessed value and the tax rate was 120 mills, you would pay \$1000 X .120 = \$120 in taxes.

If your home was valued at \$100,000, and you were eligible and had signed for homestead exemption, you would calculate your taxes as follows:

\$100,000 (Fair Market Value)

X 10% (Level of Assessment)

\$10,000 (Assessed Value)

-\$7,500 (Maximum Homestead Exemption)

\$2,500 (Taxable Value)

X 0.120 (Tax Rate)

\$ 300 (Total Parish Taxes Due)

Note: Homestead exemption does not apply to mileages assessed specifically for Monroe City.

To calculate the taxes on your business: Property taxes (millage rates) are levied on 15% of the assessed value of the business. For example, if the millage rate is 120 you would pay \$120 per \$1000 increment of 15% of the market value. An example is provided below for a representative business valued at \$100,000 and a millage rate of 120.

Because of the projected size of the V-Vehicle investment/production plans, growth forecasts for the Northeast Louisiana economy are decidedly different with and without V-Vehicle in the equation.

As indicated in the table, The 5-year growth of full-time equivalent employment from new economic activity in the region is projected to be 4.8% if V-Vehicle operations achieve their projected level. Without V-Vehicle, however, forecast 5-year employment growth diminishes to a projected 2.1%.
