Article VII.Section4: change second sentence to: 'The secretary shall make available a summary report of the business transacted in accordance with the LA open meetings law.'

Article VII.Section5: change first sentence to: Meetings of the faculty senate are regularly open to attendance in accordance with the Louisiana open meetings law.

Article VII.Section7: Change wording to something such as: The order of business for faculty senate meetings shall include the following but additional items may be covered and the sequence can be adjusted.

a. Call to order
